1 Entrance fee

The entrance fee for an initial certification is set out in the table below:

Payment of the entrance fee is a prerequisite for the execution of the initial visit. The entrance fee cannot be reimbursed if the application does not lead to certification.

2 Evaluation (inspection)

The cost of the evaluation (inspection) is determined as set out below:

1. Personnel:
 - Auditor and/or assessor cost 130,50 €/HR
2. Travel:
 - In Belgium: fixed rate for the use of the car and the time of the personnel 383,29 €
 - Abroad:
 - rate of € 0,4425/kilometer for the use of the company car
 - other necessary travel expenses at actual cost

Remarks:

- a) PROCERTUS adds 30% to the charges for the BENOR mark and 38% for the CE mark and PROCERTUS mark (for operating costs, coordination costs, accreditation management costs, use and control of the licence, etc ...)
- b) The entire inspection time is charged: examination of technical file, preparation of visit, visit duration, duration of travel, preparation of report, meetings, ...
- c) Cancelled visit: In case of a visit cancelled less than 48 hours beforehand by the certificate holder (incl. distributor), an amount of € 517,04 will be charged. In addition, for each cancelled visit, all costs already incurred will be charged.

- d) The inspection cost for the distributors of BENOR steel is already included in the certification fee.
- e) The inspection cost is determined at a flat rate based on the specific situation and history of inspections in the company. This flat rate may be revised annually based on the previous year's actual costs. If this history does not yet exist, such as for an initial certification, the actual cost will be charged. Real costs are also charged for travel abroad.
- f) PROCERTUS reserves the right to provide certain services only upon advance payment of them, or upon payment of an advance upon approval of the offer.

3 Contribution after granting the certificate

The contribution after granting the certificate is fixed in the table below:

¹ The calculation of the billing amount for year n is based on the tonnage of BENOR steel purchased directly from producers in year n - 1 on the assumption that the certificate was valid throughout the whole year n - 1. If the latter is not the case, the billing amount is based on the purchased tonnage in the period covered by the certificate of year n.

² The fee is due by civil year and is indivisible. The fee remains due during a suspension (voluntary or not) of the certification. If the entrance fee had already been charged in the same civil year, no yearly fixed contribution is due. The contribution based on tonnage is due from the date of granting the certificate.

4 Costs of the control tests

The costs of the external control tests are paid according to the tariff of the control laboratory chosen among the list of subcontractors. The tariff can be directly obtained from the chosen laboratory.

5 Payment and invoicing

The yearly contribution to the certification is invoiced at the beginning of the year.

If a flat rate can be determined for the inspection cost for the full year (e.g. BENOR certificate holders in Belgium), this amount is divided per quarter and invoiced at the beginning of each quarter.
